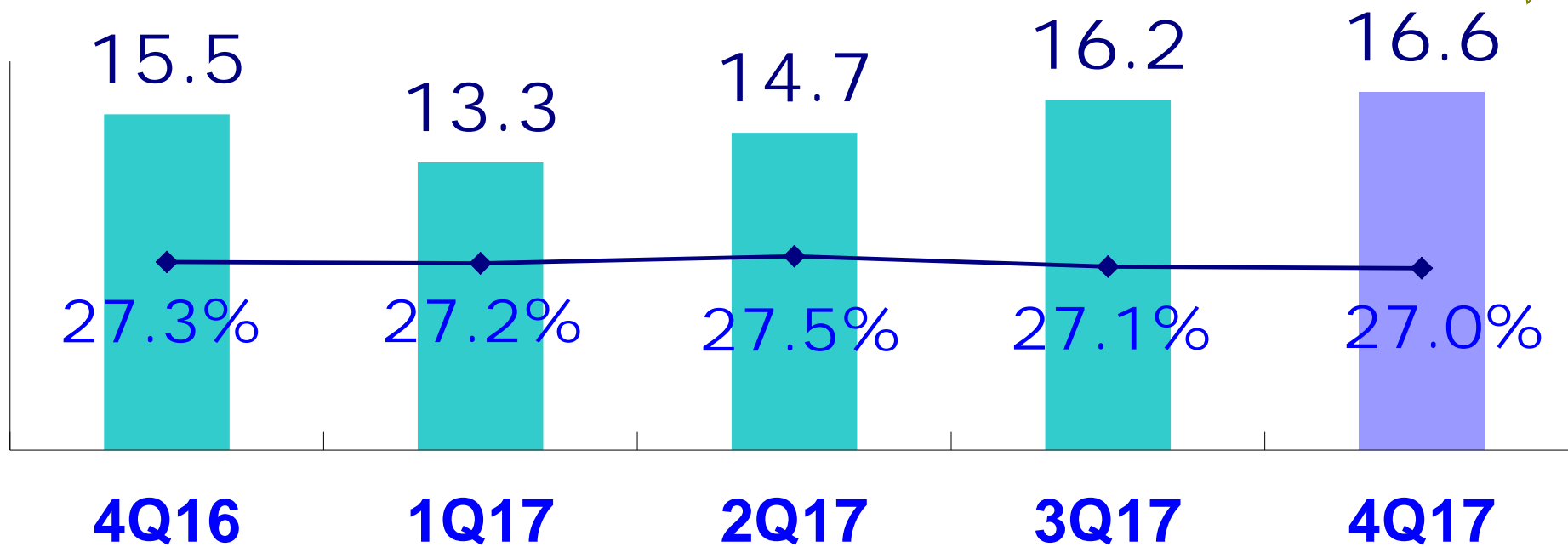

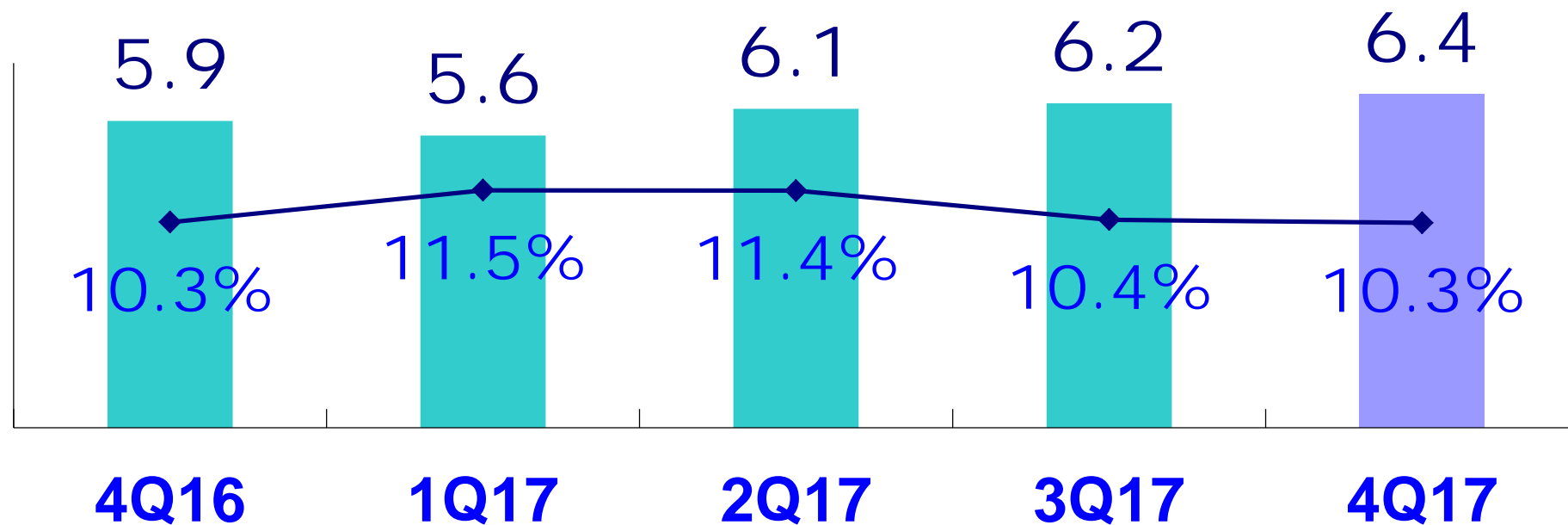

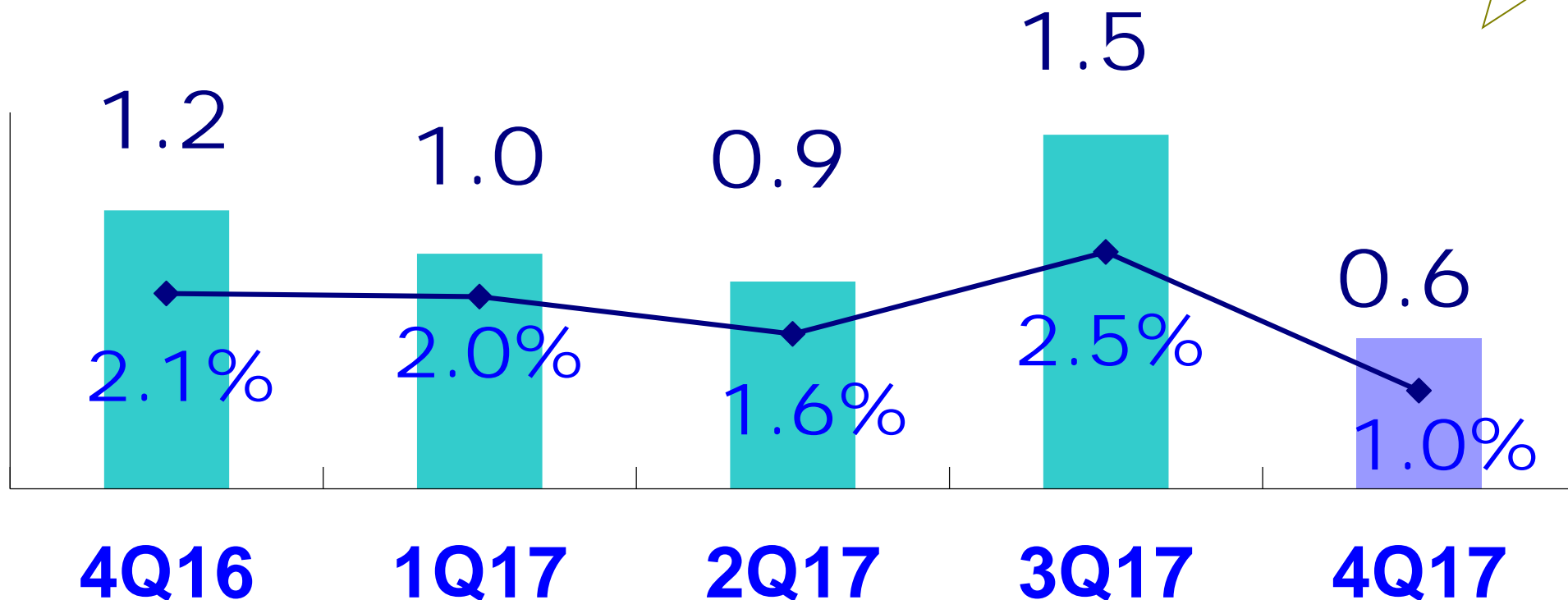

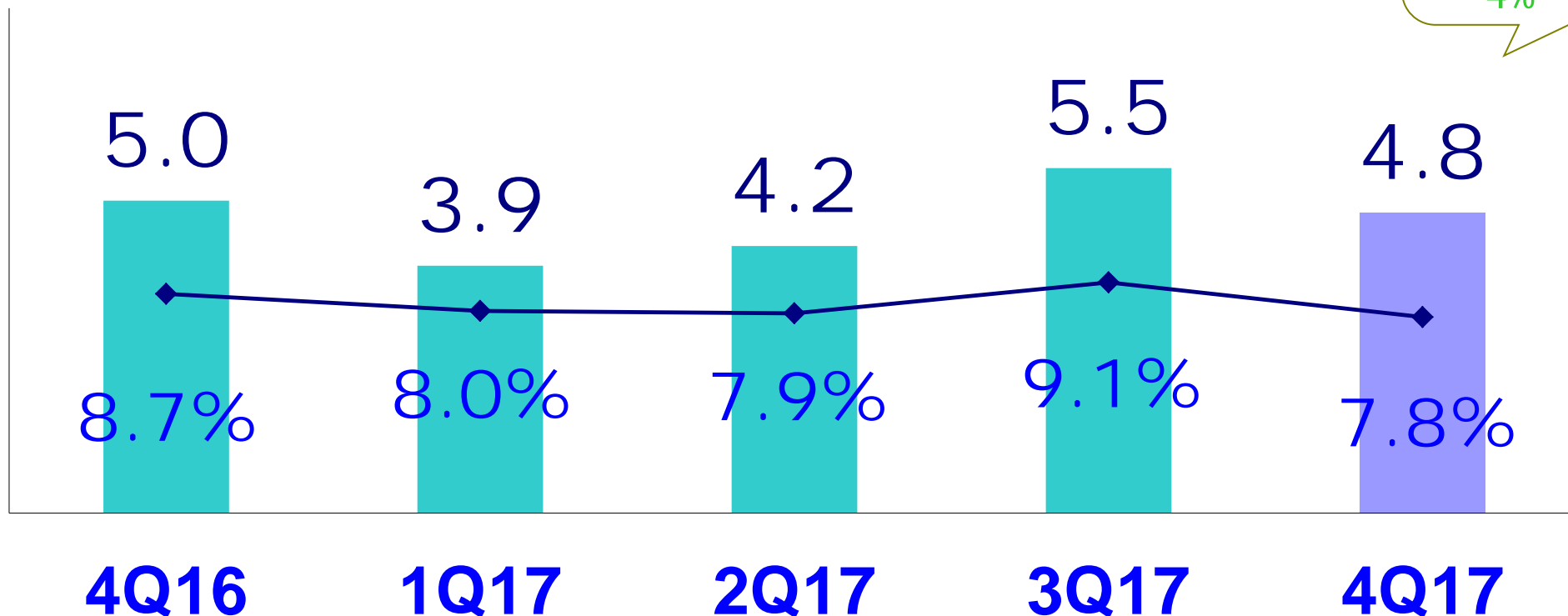

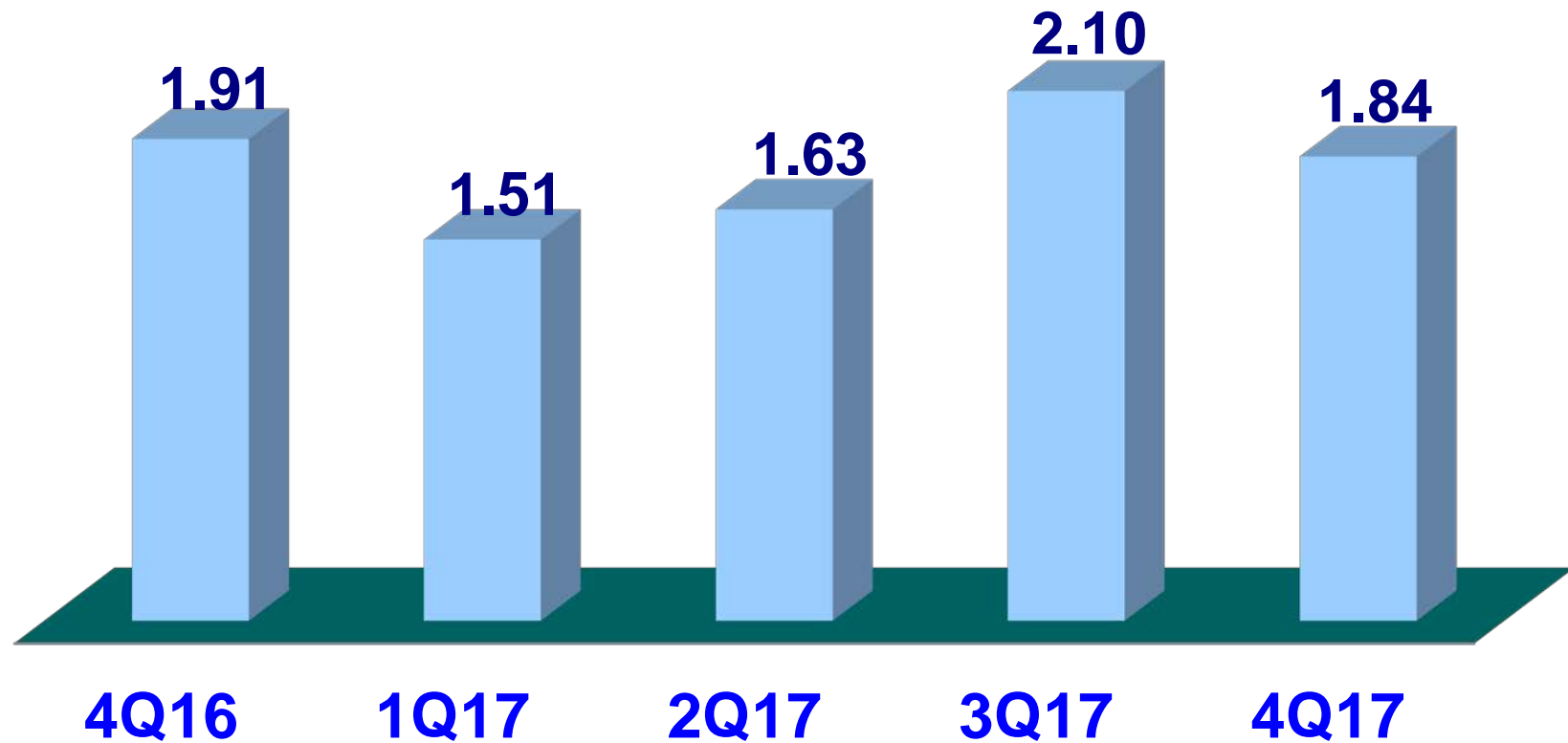

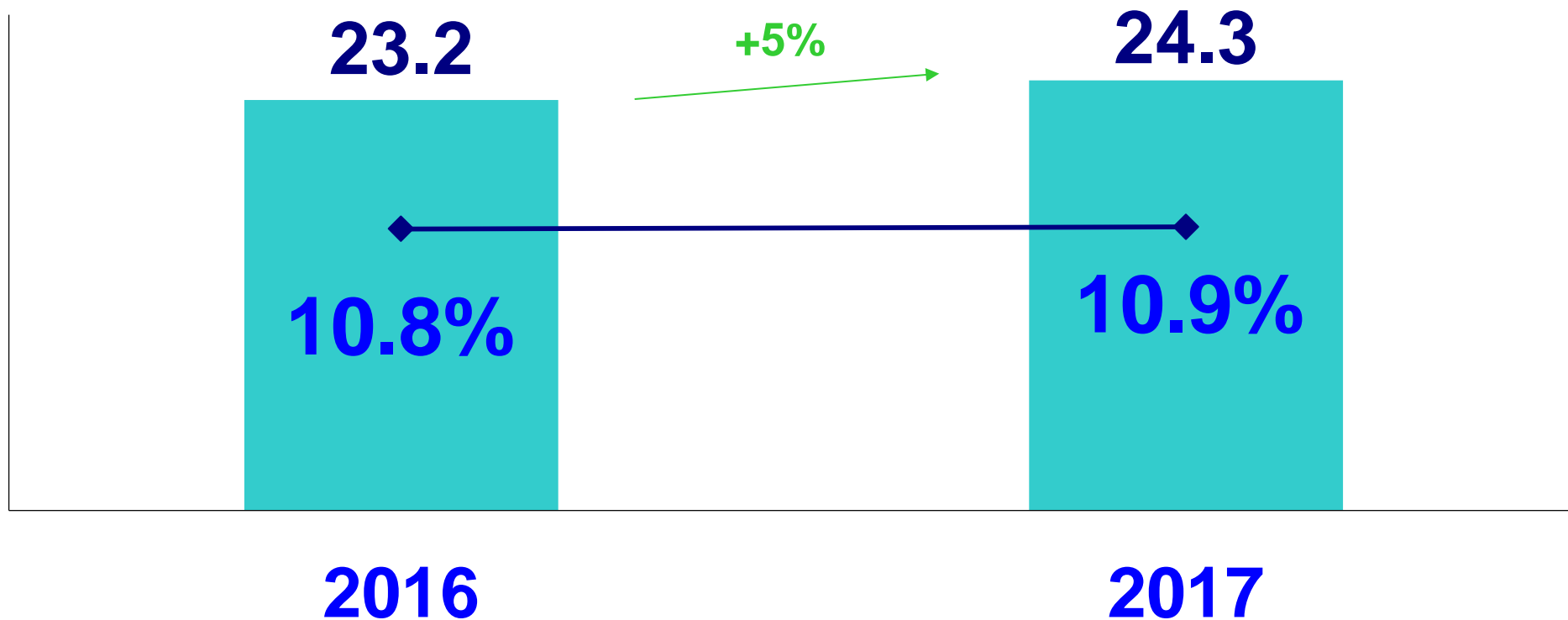

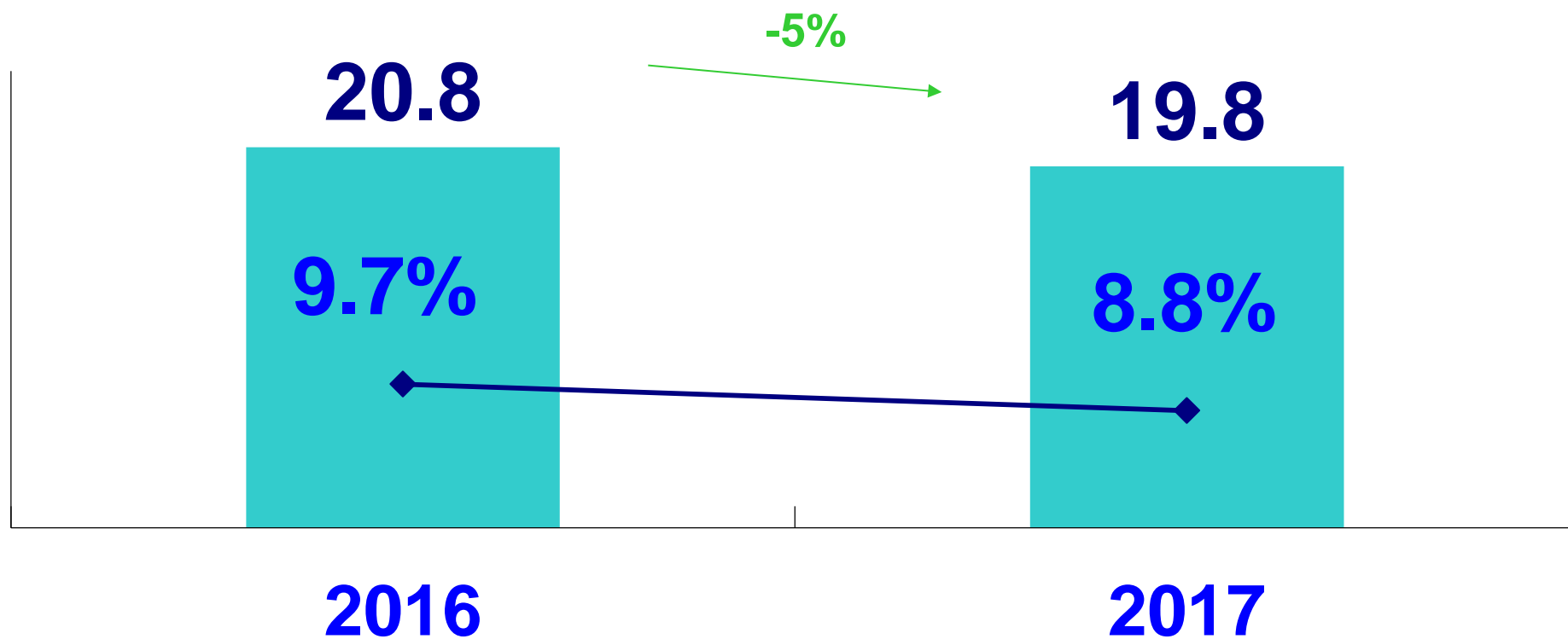

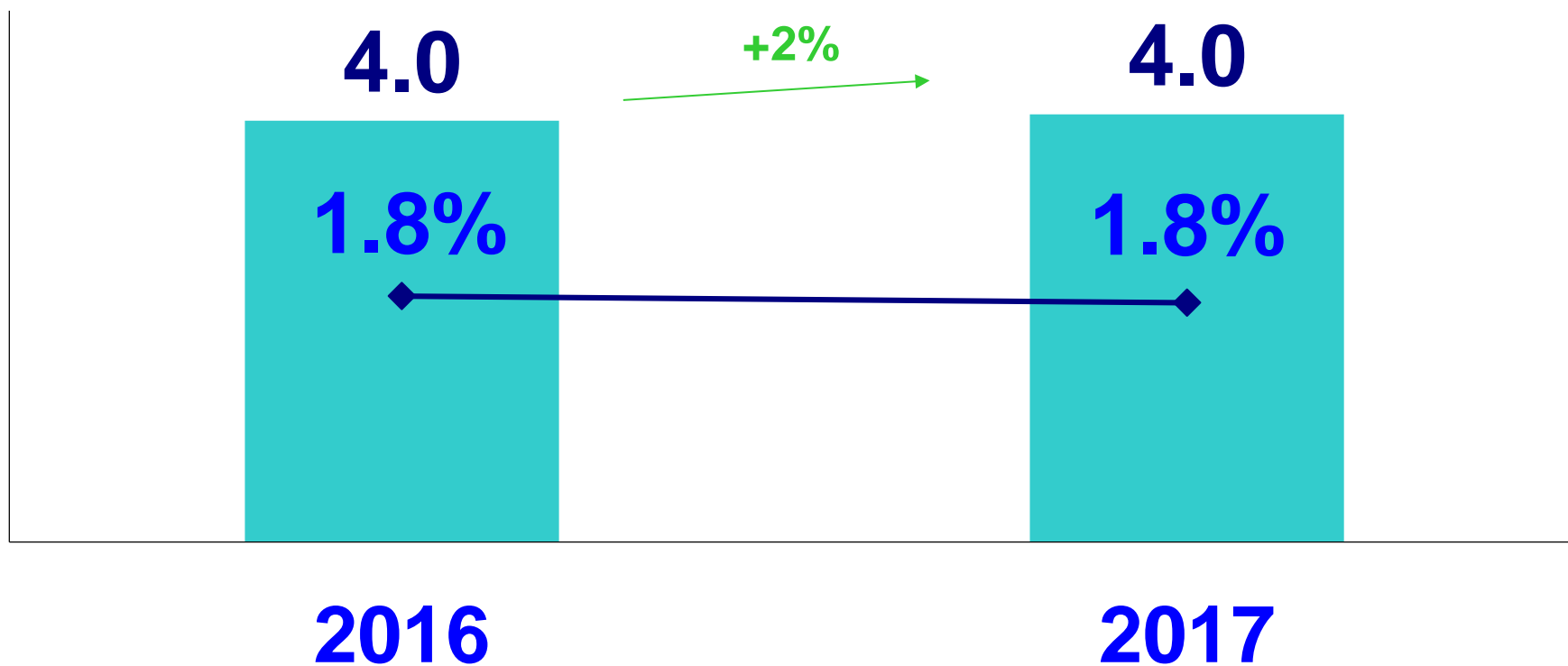

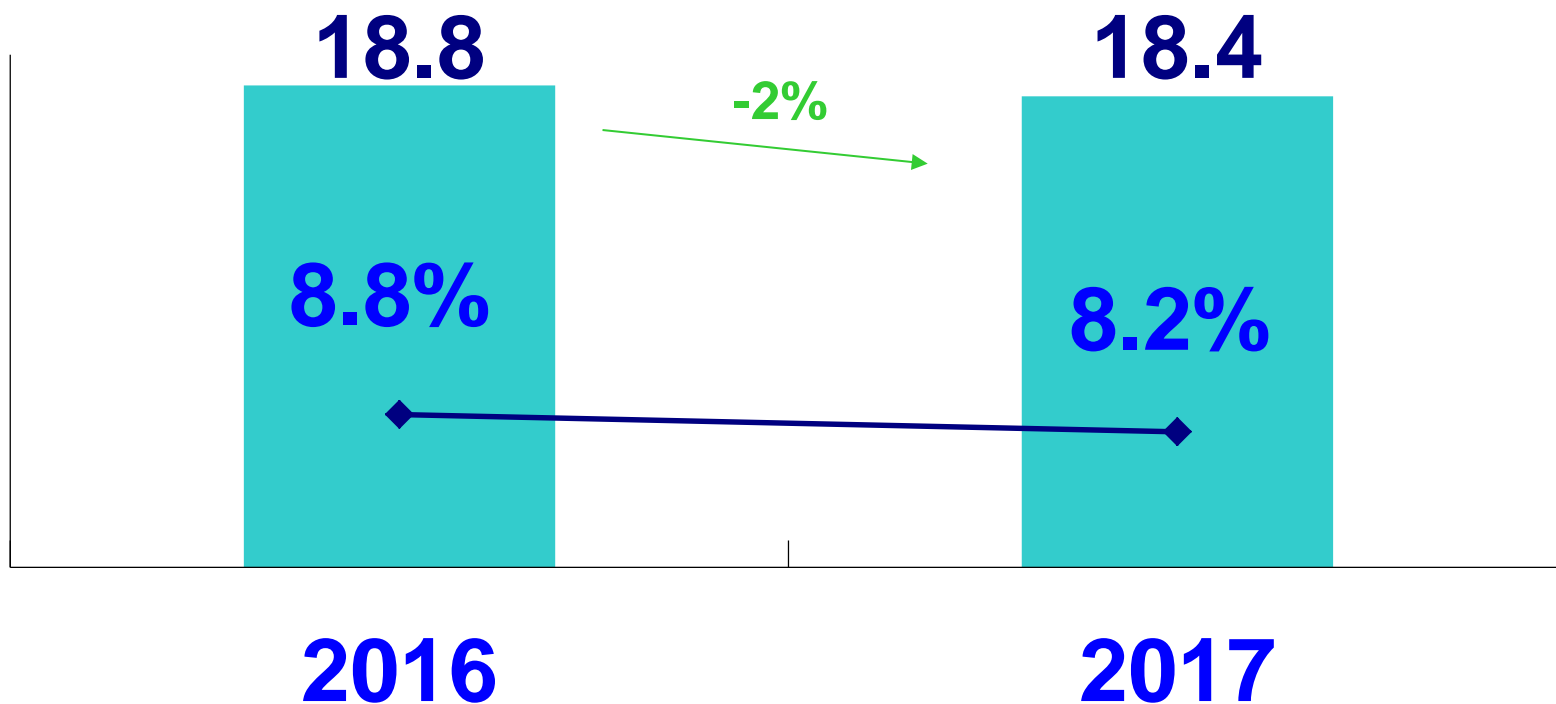

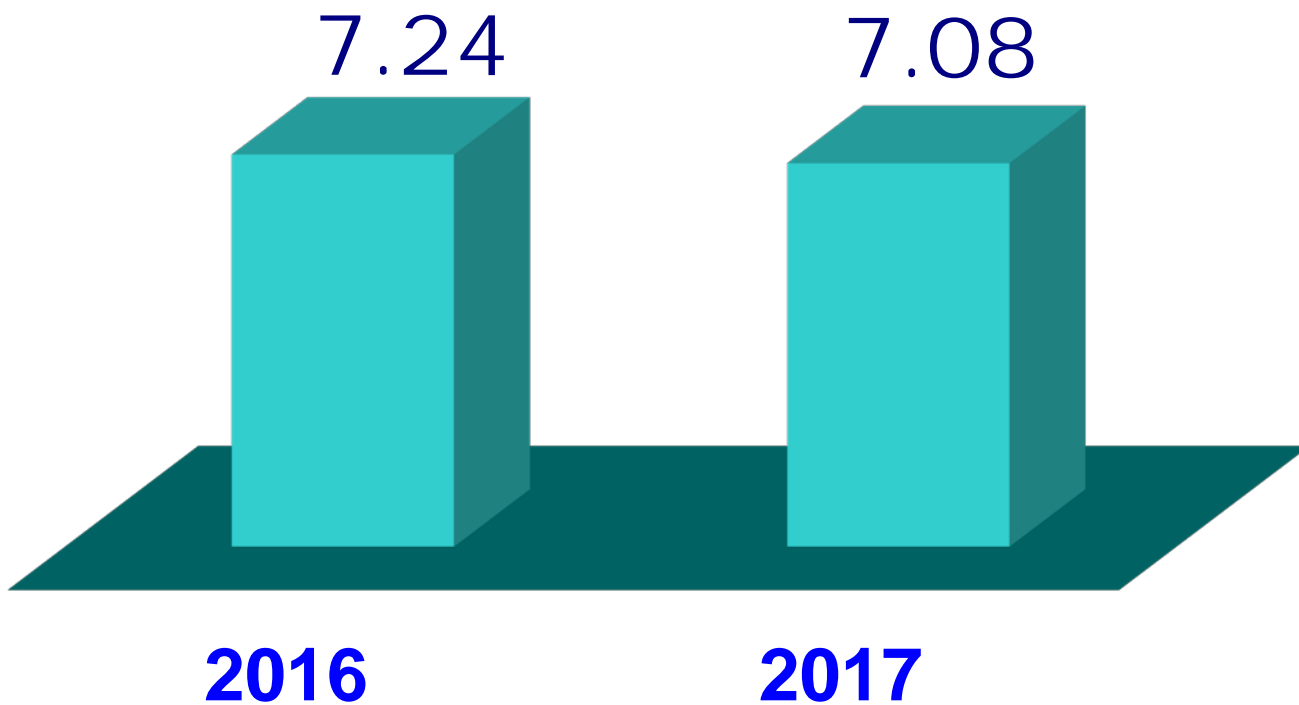
Net Profit after Tax
